Dear Scholarship Applicant:

Thank you for your interest in the scholarship application made available through the Nebraska Grocery Industry Association (NGIA).

Three different scholarships are available. This application is for the category of “Non Traditional Student.” Eligibility is limited to those who either work for an NGIA dues paying member or who has an immediate family member who works for an NGIA dues paying member. Eligibility for Wholesalers and Associates is limited to those employees who are employed in Nebraska.

Applicants should be aware that failure to follow explicit directions on the application could place your chances of receiving a scholarship in jeopardy. Any application received without all supporting documentation will be forwarded on to those who grade the applications and lack of documentation will be considered when determining the total point values for each applicant.

All applications must be:

1. Hand delivered to the address listed on the letterhead above; or
2. Mailed to the address listed on the letterhead above; or
3. Emailed to [afellers@nebgrocery.com](mailto:afellers@nebgrocery.com)

Applications must be received in the NGIA office from January 1 thru April 1. Any applications that are received after April 1 will be considered ineligible for consideration. Those applicants who email the application should send a copy to themselves to assure delivery. Once an application is received, NGIA will confirm receipt. If you do not receive a receipt confirmation, please resend your application. NGIA is not responsible for any “bounce backs” or undelivered scholarship applications.

Scholarship winners will be announced by May 10th. If graded results are received by NGIA prior to May 10th applicants will be notified earlier. An email will immediately be forwarded to NGIA dues paying members if the applicant who works for them is a winner. All scholarship applicants will be notified, via email, if they are or are not a winner. If an email address is not provided, the applicant will receive a letter informing them of their status.

4. Official acceptance letter from college or vocational school.
5. SAT and/or ACT scores if they don't appear on official transcript, if you took these exams within the last five years.
6. One letter of reference. Letter of reference should include:
  - Name of letter writer
  - First and Last Name of the applicant whom the letter is written about
  - How long he/she has known the applicant and in what context
  - Description of the applicant's character, achievements, and ability to set realistic and attainable goals
7. One letter of recommendation from current employer. Letter of recommendation should include:
  - Name of employer
  - First and Last Name of the applicant whom the letter is written about
  - How long he/she has been employed by the employer and in what context
  - Description of the applicant's character, achievements, and ability to set realistic and attainable goals
